### **Terms and Conditions**

#### *Reservation/ Damage/ Security Deposit*

- A reservation deposit of \$100 is payable upon booking and is applied to the rental fee at the time payment is due. Payment can be made by cash, cheque, money order, travelers' cheque, Visa, or M/C.
- NSF fees: \$40.00.
- A Damage/Security deposit of \$500 (CND) per week, or portion of, will be charged and due with the rental fees. (Cash, Cheques and postdated cheques are preferred to keep costs to our customers reduced.)
- All rental fees and taxes must be paid prior to rental. If paying by postdated cheque, please allow 7 extra days for bank processing.
- Damage/Security Deposit will be returned in full upon satisfaction of the renter that the unit is clean and undamaged. Allow up to five business days to assess and process your deposit refund.

#### *Insurance*

- Full insurance including 2,000,000-liability insurance is included in the rental price.
- A deductible of \$500 per accident that will be charged or the actual cost of the repair plus 15% will be charged, whichever is less, to the credit card on file and/or deducted from the damage deposit. In the event of an accident, the damage deposit will be applied to this fee.
- **All repairs require pre-authorization.**
- A police report must be filed in case of any accidents.
- Personal property is not covered (i.e. whatever you are hauling).
- It is recommended that you purchase appropriate insurance to cover your property.

#### *Cancellation policy*

- Cancellations will be accepted up to 7 days from the rental date.
- Cancellations after that will be charged the full rental fee, unless the unit can be re-rented.

#### *Pick up and return*

- Rental is on a 24 hour basis. A week is considered 7 days. A weekend is Friday 5 pm to Sunday 5 pm.
- Pick up time is from 7 am until 6 pm at the latest.
- **Unit must be returned on time unless otherwise agreed.**
- Late fees of \$50.00/hr apply.

#### *Towing Requirements*

- Minimum GVRW of 3500 lbs and a Class III receiver hitch are required.
- Renters must have the appropriate wiring and hitch with a 2" ball.
- Electric brakes may be required. You may haul up to 40% of your tow rating before requiring the brakes.
- It is the renter's responsibility to know their towing ability and vehicle's towing capacity and take full legal responsibility should they underestimate their vehicles towing capacity.

#### *Return Preparation and Cleaning*

- It is expected that the unit be returned in the same condition to which you received it. Any damage is the sole responsibility of the renter.
- Clean the trailer. Wrap straps neatly and stow in toolbox.
